Today, the FTC filed a proposed order governing redress along with a motion summarizing the redress plan and seeking the order's entry. The FTC will serve the Defendants and certain additional potentially interested parties. The FTC understands that the Receiver will serve other interested parties, including lot purchasers. Additionally, applying expertise in consumer communications, the FTC has further summarized certain plan elements and addressed likely questions through a Frequently Asked Questions ("FAQ") page on its website. The Court also directed the FTC to propose a schedule for submissions concerning the proposed plan. Although the need to commence redress quickly is critical, at least some time beyond what the Local Rules require is appropriate. Accordingly, the FTC proposes:
